TRUST DEED

This Trust Deed is made today the 1st day of October'2021 at Chhachhrauli (District Yamunanagar), by Shri Narinder Kumar son of Shri Yash Pal aged about 53 year, resident of House No.34, V.P.O. Bilaspur, Tehsil Bilaspur, Distt: Yamunanagar (hereinafter called as "Settler")

Whereas the abovesaid "Settler" is desirous to create a Trust for the educational and charitable purpose. The contents of this trust have been approved by the settler in the presence of all other trustees as per list given in this deed in its meeting held on 1st day of October'2021. In the said meeting it was further decided to get the trust deed registered with the Sub Registrar, Chhachhrauli.

And whereas the abovesaid Settler is desirous to donate to donate a sum of Rs.5,100/- (Five Thousand One Hundred only) for the initial working and running of the said Trust. However all the founder trustees for achieving the objectives of the Trust will invest the required money, in future.

Now this deed of Trust Witnessed as under:-

1. **Name of the Trust:-** The Trust shall be called "MAA KARMAWALI EDUCATIONAL & MEDICAL TRUST, Bilaspur (hereinafter referred to as the "TRUST"
2. **REGISTERED OFFICE:**
 - a). The Head office of the trust shall be stipulated at VPO Bilaspur, Tehsil Bilaspur, Distt. Yamunanagar in the State of Haryana. It may be shifted to any other place as decided by the Managing Committee from time to time.
 - b). State Level Branch Office(s) and Sub Branch Office(s) shall be opened to run any where/ within the Territory of Indian Union.
 - c). State Level Branch Office(s) and District Sub Office(s) shall function in accordance with the instruction issued from Head Office from time to time.
3. **AREA OF OPERATION:-**
Whole of India, especially State of Haryana.
4. **AIMS AND OBJECTS:**
 - a). MAA KARMAWALI EDUCATIONAL & MEDICAL TRUST is established for setting up of Educational Institutions Solely for educational and charitable purpose.
 - b). To work for upliftment of Education i.e. Technical, Higher Education, Professional Education and Medical/ Health Education etc. and to promote and develop education, employment, science and technology and prosperity of Humanity by way of establishment of different education, Research & Training Institutions. The Institutions can be opened in any part of India/ State under any name as per resolution passed by the Founder Trustees.
 - c). To help the poor/ needy and intelligent students and their welfare and to spread education in the society at large. Special emphasis shall be done on the welfare of SC/ST, backward casts & women economically backward persons etc.
 - d). To establish schools(s), College(s), Institution(s), Technical/ Professional, Entrepreneurship/ Scientific Development Organizations and opening Hospitals etc for the welfare of the society. The same can be opened in any state or union territory of India. Also to develop agriculture and Biotechnology & Industries related to education research work in all the emerging areas including opening of Hotel/ Motel/ Resorts.

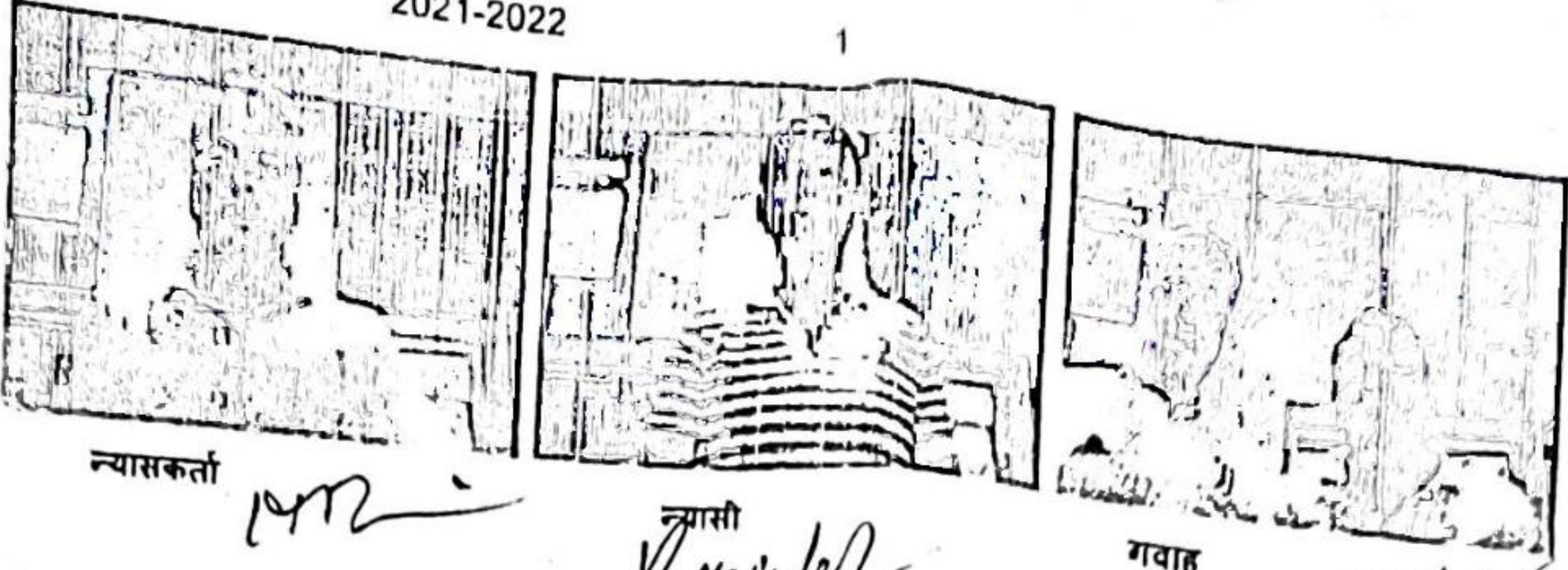

- e). The trust is not established for the purpose of profit no part of the corpus income or reserves of the trust shall be applied directly or indirectly for the benefit of the Settler, Trustees or members or their relatives or any other persons specified under section 13 of IT Act 1961 as amended time to time or any other legislation governing the exemption of income of Charitable Trust in force.
 - f). To be charitable and cooperate with other professional bodies, trust/ society and with educational and research institution having similar objects.
 - g). To open Charitable hospital, to uplift the poor section of the society, to give scholarship to the needy, to arrange marriage of poor girls, to open old age homes and maintain facilities for destitute deaf and dumb and to uplift the poor section of the society through lectures & demonstration and advertisements etc.
 - h). To Establish Entrepreneurship Development Centre(s) and /or STEP and / or TBI and to conduct EDPS/ MDPS/ TEDPS/SDPS etc for the promotion of business Entrepreneurship in the Country.
 - i). To give donations to Authorised/ recognized bodies for welfare of needy persons or to mitigate their hardships.
 - j). To process properties and funds, to receive donations & to administer and deal with them for the object of the Trust.
 - k). To apply to the Central Government and State Government and other Institutions for allotment of land and building for the formation of educational institutions such as School, Public School, College, Charitable, Hospital etc. and for receiving grant(s) to fulfil the objectives of the Trust and to arrange donations to running the same.
 - l). To adopt any running educational institution(s), hospital or any other organization(s) already working and giving education of the society as a large for uplift the standard and to help management financially as well as educationally.
 - m). To accept, purchase, receive, take on lease or hire or otherwise acquire any moveable or immovable property, rights and privilege.
 - n). To do all other such acts and things as may be necessary to the attainment of the aforesaid objects as may fall within the purview of the Trust Act and keeping in conformity with the law of land.
5. The Trust shall have a succession, shall have a common seal and can sue & be sued by the said name.
6. All the income of the Trust shall be utilized only for the betterment of the Trust and its aims and objectives.

7. **DEFINITIONS:**

In this deed unless the context otherwise requires:

- i). Managing Committee shall mean the Managing Committee constituted under these Rules and Regulations.
- ii). President shall mean the President of the Managing Committee of the Trust;
- iii). General Secretary shall mean the General Secretary of the Managing Committee/ Governing body of the Trust.
- iv). Treasurer shall mean the Treasurer of the Managing Committee/ Governing body of the Trust

- v). Committee or Sub Committee shall mean any committee set up by the Managing Committee to assist in the furtherance of its objects.
- vi). Officers and Staff shall mean every officer and staff member appointed by the managing committee/ Governing body to any office in the trust and institutions.

8. **MEMBERSHIPS:**

- I. Founder Trustees
- II. Life Members
- III. Honorary Members.

i). **FOUNDER TRUSTEES:-** The Founder Trustees are 4 (four) including the Settler at present and the same can be increased/ alter as per the sole decision of the President, in future. The Names and Addresses of all the Founder Trustees have been mentioned in this Trust Deed. New Trustees in this category will be accepted only through an application as per need of the time & trust's requirement etc. and initial fee of Rs.2,51,000/- (Rupees Two Lacs Fifty One Thousand only) will be accepted, in the name of the trust. once President finalize the same and gives his/ her consent in willing to the concerned person, No appeal lies against the decision of the President for acceptance/ rejection of membership in this category.

In case of any vacancy due to death, voluntarily retirement etc. of any founder trustee, the vacancy will be filled from his/ her legal heirs or any his/ her will, but if there is no legal heir or the legal heir are unfit to become Trustee of the Trust, the Managing Committee/ Settler is at liberty to co-opt any person from the families of the founder Trustees as Trustees in his or her place.

But in case of dispute among legal heir for the Founder Trustee then the President can make any legal heir as Trustees against the vacancy and no legal action can lie against his/ her decision.

ii). **LIFE MEMBERSHIP:** Any individual not below the age of 18 years with sound mind and is in the agreement with aims and objectives rules and regulations of the Trus shall be eligible to become life member of the Trust subject to the approval of the Managing Committee without the power of vote. The desirous persons shall have to apply to the President on the prescribed membership form. The Managing Committee shall have the full power to accept or reject the form with or without any reason. However decision of the President shall be final.

iii). **HONORARY MEMBERS:-** Any person who is considered to prove beneficial to the trust may be co-opted as honorary member by the President/ Managing Committee without the power to vote. He may be assigned any work to do by the President.

9. **MANAGING COMMITTEE:-**

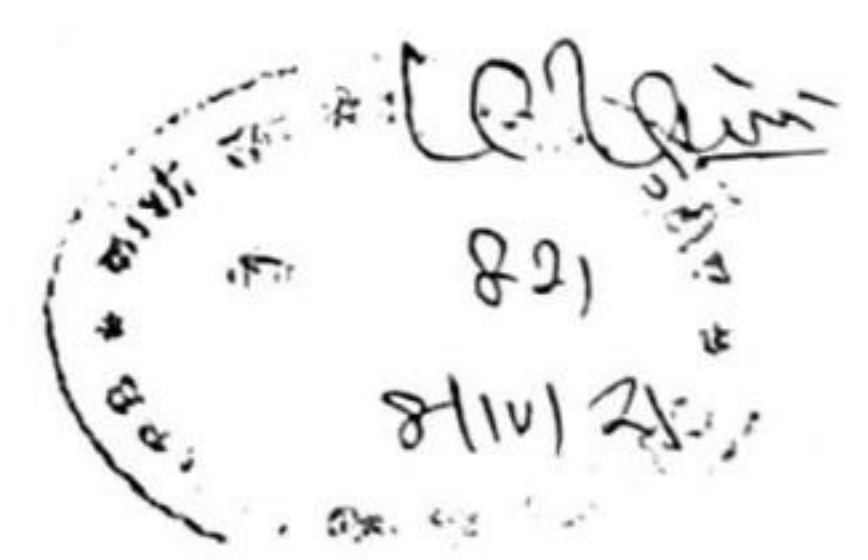

- a). The President, General Secretary and Treasurer shall be elected for 10 years term and shall be eligible for re-election by the founder trustees. The election of the next term will be by way of 3/4th majority of the total founder members. In case of the President will be fully competent to decide the name as he deems fit in the larger interest of the trust.
- b). For any professional done work trustees are allowed to take salary/ information as per the competency.
- c). The meeting of the Trust will be called by the General Secretary on the instruction of President. The notice of the meeting will be served on the trustees with at least seven days time.

- d). The managing committee shall meet at least once in every 3 calendar month 3/4th members shall form quorum of the meeting.
- e). Managing Committee shall exercise the following Powers:-
- i). To purchase, lease or otherwise acquire any immovable and moveable property or properties.
- ii). To receive grants, donations, contributions and gift, whether in cash or kind admission & tuitions fee etc.
- iii). To open Bank Account/ accounts with such scheduled bank/ banks and to operate such bank account/ accounts.
- iv). To deposit all the money belonging to the Trust in such bank accounts or invest the same in specified securities as prescribed under section 11(5) of the Income Tax Act, 1961 or any other relevant legislations as may be applicable for the time being to regulate the deposit of the funds of the trust to be eligible for the time being. To deposit all the moneys belonging to the Trust in such Bank accounts or invest the same in specified securities under section 11 (5) of the Income Tax Act.
- v). To utilize the whole of the income of the Trust (how so ever delivered) towards carrying out the objects of the Trust.
- vi). To maintain proper accounts and other relevant records and prepare an annual statement of account including the Receipts & Payments Account and the Balance Sheet as prescribed under the law and to get the same audited from the eligible Chartered Accountant.
- vii). To fill any vacancies, how so ever created, in the Managing Committee or otherwise.
- viii). To suspend or terminate membership of any member of the Trust because of valid reasons recorded by the Managing Committee.

- ix). To appoint and constitute such Body/ Bodies, Committee/ Committees, Sub Committees, as may be deemed fit and found necessary, to delegate all or partial powers to the said Governing Body/ Bodies, Committees, Sub Committees or to the Offices and / or any other officer as may be deemed fit and found necessary for furtherance of the objects of the Trust.
- x). To Raise Loan from any Financial Institution/ Bank/ Person or Trust at such terms and conditions as may be decided and approve by the managing committee and also to mortgage the trust property whether moveable or immoveable for securing such loan.
- xi). To employ necessary staff, on such salaries and wages as may be determined and to make steps and measures for their welfare.
- xii). To give loans or deposit to any other Trust at the discretion of the Committee.
- xiii). To do all such other lawful acts, deeds or things, either alone or in conjunction with other organizations, as are incidental and conducive for the attainment of the objects of the Trust.
- xiv). To make bye-laws, Rules/ regulations etc. for the conduct of the affairs of the Trust & to add, amend, vary or rescind the same from time to time as may be permitted under their law and as decided by the Managing Committee.
- xv). To purchase, sell or to take on lease, hire, accept, transfers or otherwise to acquire any moveable or immoveable property/ properties as may expending for the purpose of the Trust.
- xvi). To appoint, suspend, dismiss or discharge the employees of the Trust and/ or take disciplinary action, as may be deemed fit and necessary.
- xvii). To enter into, carry out, rescind, modify or cancel any contracts on behalf of the Trust.
- xviii). To institute, conduct, defend or abandon any legal proceedings by or against the Trust and also to compound any claim or demand by or against the Trust and to take all steps as required and deemed fit and necessary.
- xix). To remove any member or conduct or behaviour prejudicial or deter mental to the Aims and objects of the Trust after due notice or such members.
- xx). And generally to regulate the affairs of the Trust and look after the properties, funds and finances of the Trust.

11. PRESIDENT

The President shall be elected for 10 years (Ten years) terms and shall be eligible for re-election by the Founder Trustees.

The Powers and duties of the President shall be:-

1. To preside over the meeting of the Trust. The President shall be Chief Executive of the Trust and shall be responsible for general administration.
2. To see that the constitutions, rules and regulations are faithfully observed.
3. To be responsible for the better financial management, progress of the Trust and the Institution of the Trust.

4. The President of the Trust Shall be fully competent to constitute and dissolve Committee whatsoever within the constitution with the consent of the Managing Committee.
5. The president shall be empowered to sanction the bills upto an amount of Rs.1,00,000/- (Rupees one lacs only) subject to total of Rs.5,00,000/- (Rupees Five Lacs only) in a calendar month but the same shall be increased with the approval of the Managing Committee.
6. The President is fully competent to borrow money on such security as shall be specified in the resolution of the trustees/ Managing Committee and for that purpose sign, seal, deliver and execute such deeds, documents and writings and do such acts, deeds, matters and things as may be deemed necessary.
7. The President is fully competent to apply for the establishing new Technical Institution/ Colleges or for applying for new Courses in its existing colleges or for establishment of University/ Universities and to earmark Trust's land/ building and funds required for the same with the consent of Managing Committee.
8. The President is fully competent to enter into any agreement with any body society or trust under any act of parliament, working in the field of education for establishment of any school, institution, or college under the brand name of that particular society trust etc. with the consent of Managing Committee.
9. The President shall be ex-officio chairman of all the committee approved by the Managing Committee.
10. The President can appoint, dismiss, transfer, promote employee(s) or otherwise punish the employee(s) of the Trust and off all the branches and institutions with the consent of the General Secretary and the same is to be put up to Managing Committee next meeting.
11. The President shall also operate upon the trust bank accounts jointly with the signatures of General Secretary/ Treasurer.

12. **SECRETARY-CUM-TREASURER:-**

The Powers and duties of the General Secretary shall be as under:-

1. The Secretary—cum-Treasurer shall work under the control of the President of the Trust and shall be responsible to the President for all such actions.
2. The Secretary-cum-Treasurer shall on the instructions of the President/ Managing Committee call the meeting of the Managing Committee and for that purpose circulate lettes to the members, prepare agenda for the meetings, record the proceedings of the meetings, conduct correspondence on behalf of the trust and look after the properties of the trust. Annual General Meeting, extra ordinary meeting, routine meeting will be called by him as per the President's instruction.
3. He may get honorarium and enjoy such facilities as the Managing Committee may deem fit.
4. He shall be responsible for regular and proper maintenance of the accounts of the trust, annual receipts & payment accounts, Balance Sheets and other statement of accounts and all its branches and institutions.
5. To prepare and present the budget estimates, audited accounts of the trust on the dates.

He shall be empowered to sanction bills, such as Rs.75,000/- (Rupees Seventy Five Thousands only) but such total amount will not exceed

Rs.2,50,000/- (Rupees Two Lacs Fifty Thousands) in a month. The abovesaid monetary limits may be increased by the managing committee considering the needs from time to time.

7. The General Secretary shall supervise the income & expenditure of the Trust, sanction the payment of the bills, sign papers on behalf of the trust and generally to do all such things and acts which may be deemed necessary to carry out his duties.

13. **REMOVAL FROM MEMBERSHIP:-** President is fully empowered to remove any founder Trustee, any life member or honorary member of the trust (with or without giving any notice) or any of the following grounds:-

- i). For acting in any way prejudicial to the interest of the Trust.
- ii). Failing to pay the subscription/ any amount due to the Trust.
- iii). Have failed to perform the duties entrusted to him.
- iv). Leakage of any confidential matter etc.

14. **FORMATION OF MANAGING COMMITTEE:-**

The 1st Managing Committee have already given in this trust deed.

The Governing body with the consent of the President will formulate and implement programmes for the promotions of the aims and objectives of the Trust.

Governing body will arrange funds, appoint the necessary staff and create infrastructure and it will also monitor the implementation of the projects run by the Trust.

15. **PROCEEDINGS OF THE GOVERNING BODY/ EXECUTIVE COMMITTEE MEETING(S):-**

The General Secretary shall record within thirty days minutes of proceedings of the Committee meetings in the Minutes Book kept for the purpose after getting the same approved by the President of the said meeting.

16. **WINDING UP OR DISSOLUTION OF THE TRUST:-**

Assets and liabilities accrued by any authorized office bearer/ member of the trust, all its branches and institutions will be property of the Trust. If the trust fails due to some or other grounds, it shall be merged with same other trust with similar objects and if purpose of the trust changed, the same will also be charitable in nature with the resolution of Trustees passed by $\frac{3}{4}$ majority.

The duties of all the officers and members shall be to work for the betterment and progress of the Trust.

17. **SUPPLEMENTARY PROVISIONS:-**

Auditing of accounts:-

The accounts of the Trust of all its branches and of all its institutions shall be kept separately and all annually be audited by the chartered auditors appointed by the President with constitution of Secretary.
